

Redus Sizzles In 220

Clint Redus ran the fastest 220-yard dash by a San Francisco high school competitor this season as he led defending champion Washington through City Meet qualifying yesterday at Kezar.

The Academic Athletic Association record holder in the high hurdles, Clint clocked :22.4 in his furlong heat. He also qualified in the high with :15.1.

Washington landed 17 places in Thursday's semifinals. Lovell placed 16, Poly 14 and St. Ignatius 11. Varsity field trials will be held today, beginning at 3 p.m.

Dick Bullock of Lowell, Redus' key adversary this season, won his high hurdles heat in :15.1 — same time as Redus — and skipped the lows in :19.8.

S. I.'s Bill Williams ran a 2:01.4 half-mile and Poly's Roosevelt Taylor a :10.4 hundred. Washington's relay team placed second in its heat to S. I. when Dave Vilner developed a muscle cramp during his lap.

Preps Gun For Track Crowns

Many Bay Area high school leagues will determine their 1954 track and field champions today and tomorrow. A raft of excellent performances are anticipated.

The schedule:
TODAY—Alameda county at Berkeley's Edwards Stadium, 3:30 p. m.; Peninsula at Sunnyvale, 7 p. m.

TOMORROW—Contra Costa county at Lafayette, 1 p. m.; North Bay at Petaluma, 1 p. m.; Catholic at Kezar, 1 p. m.

Considerable attention will be centered on the Sunnyvale meet, where new records are expected in the 880, mile, 440, pole vault and discus. Coach Lee Cox of San Jose's Lincoln High expects Don Bowden, defending State champ in the half-mile, to hit 1:52.0. Bowden has already run 1:54.1, two-tenths off the national scholastic record, this season.

Monte Upshaw, Piedmont's defending State champ in the broad jump, and X. L. Emerson, Richmond's defending titlist in the 440, figure to high light the Berkeley affair. Upshaw currently holds the Bay Area's best times in the high and low hurdles, as well as the best mark in the broad jump.

Eagles on Way to 5th Track Win

Washington became an overwhelming favorite to win its fifth straight city track and field championship yesterday by qualifying ten men in Saturday's field event finals.

Lowell, which was giving the Eagles a run for their money following Tuesday's track trials, placed only three men.

"You can write this meet off for us," Lowell Coach Don Travers said last night. "After Tuesday's trials we had everything going for us but now Washington has it so wrapped up that it is not funny."

Poly, the only other possible thorn in Washington's side, landed five places in the field event finals. Balboa placed seven.

Lowell was shut out of the discus, shot and broadjump, its strongest field events. Roger Bohne, who has done 127 feet in the discus, could do no better than 113-11 in the trials. Teammate Bob Zwieg failed to place by less than one inch.

Best performance of the day was a 21-8 1/2 broad jump by Poly's Maurice Jones. Jack Egan of Balboa threw the discus 144-3 and Pete Cordellos of Washington put the shot 50-6. All trial performances in field events carry through the finals.

Semifinal heats in track events will be held today at Kezar, beginning at 3:30 p. m.

Poly Best in Semifinals, But Eagles Still Favored

Polytechnic, determined to make Washington's trackmen hustle in tomorrow's All City meet at Kezar, flapped his wings in semifinals yesterday.

Taking a first in both 100 heats and another in a 220 heat, the Parrots nailed down five more places in the finals.

Washington and Lowell landed four more places, but both were expected to do better.

Washington remains favored to capture its fifth straight city championship, though it now appears that Poly can cause trouble.

"Don't write us off," Poly coach Steve Ebert said. "I really believe we can upset them. Our boys have caught the spirit."

Coach Lou Vasquez of Washington agreed:

"Poly can make it tough for us."

The defending champions, however, have a strong manpower advantage. The Eagles have 21 places in the finals, Poly 14, Balboa 13, Lowell 12, St. Ignatius 10, Mission seven, Lincoln five and Galileo three. The relay was not included in this tabulation.

Poly's strongest men yesterday were Roosevelt Taylor (:10.2 hundred) and Bill Cannon (10:5 hundred and :22.6 furlong). Washington's Clint Reduc clocked :15.3 in the high hurdles and :22.5 in the 220.

Lowell hurdler Dick Bullock ran :15.3 and :20.2 in the hurdles.

There were a number of disappointments.

Washington's Dave Vilner, who suffered a leg cramp earlier in the week, was unplaced in the 100 and scratched from the 220. It is questionable whether he will be at full strength for the relay.

Ravenald Williams of Lowell and Ernie Dorado of Balboa failed to place in the 100, though both have beaten some of those
