I have been informed, understand and am aware that activities such as, but not limited to running, jumping, and other fitness and movement activities, cardiovascular, flexibility and/or strength exercises are potentially hazardous activities. I also have been informed, understand and am aware that fitness and movement activities involve a risk of injury; including the risk of death or serious disability, and that I am voluntarily participating in these activities with full knowledge, understanding and appreciation of the danger involved. In consideration of being allowed to participate in fitness training and activities with CEi Fitness, facilities, equipment and services, the undersigned acknowledges, appreciates, and agrees that:

I willingly agree to comply with the stated and customary terms and condition of participation. If I observe any unusual significant hazard during my presence or participation, I will remove the hazard, if possible, discontinue my participation, and/or bring such to the attention of the nearest employee of CEi Fitness immediately.

I, for myself, my heirs, assigns, personal representatives and next of kin, do herby forever waive, release, discharge, and hold harmless Cherokee Enterprises International, CEi Fitness, and their officers, agents, employees, contractors and volunteers from any and all claims or liabilities for injuries, disability, death, or loss or damage to person or property, whether arising from the negligence or omission of Cherokee Enterprises International, CEi Fitness, Diablo Valley College, Colleges of Contra Costa, or their officers, agents, employees, contractors and/or volunteers. _____ (please initial)

I ACKNOWLEDE, BEING AWARE OF MY OWN HEALTH AND PHYSICAL CONDITION, AND HAVING KNOWLEDGE THAT MY PARTICIPA-TION IN THIS HEALTH AND FITNESS PROGRAM MAY BE INJURIOUS OR HAZARDOUS TO MY HEALTH AND OR WELL BEING, THAT MY PARTICIPATION IN THIS FITNESS PROGRAM IS VOLUNTARY AND WITH FULL UNDER-STANDING, ACCEPTANCE, AND ASSUMPTION OF ALL RISKS INVOLVED.
