Section 3. Qualifying from League to Semi-Final Meet

### **E. AT-LARGE ENTRIES**

If an athlete does not qualify for CCS Semi-Finals at his/her League Championship Meet, but his/her mark ranks as one of the top (8) performances from the League Varsity Championship Meets combined, then that athlete will be added to the CCS Semi-Final competition. This provision is for all events, including relays.

At Large entries in the 800, 1600 and 3200 events, will allow for enough at large entries to complete a full field of runners, without creating an extra heat in these endurance events.

Committee vote: 10 Yes , 0 No

Rationale: These events have so few participants and no extra heats would be created.

### **F. LEAGUE RESULTS**

1. League Representatives must submit their final League entries, after removing all scratches and inserting all alternates from their League, to the CCS Office and the Semi-Final Meet Director by 9:00am, on the Tuesday morning following their respective League Championships.
2. Once League entries are submitted for the CCS Semi-Final Meet, alternates will not replace scratched athletes.
3. League Entries will be submitted on disc next year in addition to the paper entry Form with the intent of transitioning to a fully electronic entry system the year after.

Committee vote: 10 Yes , 0 No

Rationale: Evolution to a more high tech electronic data system in the future.

**III. TOURNAMENT GUIDE CHANGES : Major Changes \*\* (Continued)**

Section 4.B.2. Qualifying from Section to Semi-Finals : FIELD EVENTS  
High Jump and Pole Vault: Events go to completion. Top eight (8) qualify for the Finals.  
**Starting Heights will be determined by Meet Management after all entries are submitted.**  
**Under no circumstances, will the opening height in any event be higher than the 40<sup>th</sup> percentile of league entry marks.**

Committee vote: 8 Yes , 2 No

Rationale: To keep in line with the State Meet format. Equipment does not always accommodate extremely low starting heights and require make shift alterations. Athlete's end up waiting hours to jump at the highly competitive heights.
