2. Need to look into numerous venue issues at SJCC, including restrooms, the markings of throwing areas, tables, loud speakers, washing of the track, watering of the long- and triple-jump pits, etc.
3. If possible, we could use benches for the athletes at the field events. Also tents for the throwers (shot and discus).
4. Trainers need to be situated so that they can provide faster and/or easier access when needed, but not on the infield.
5. Consider the possibility of rotating venues (northern and southern) each year, such as the College of San Mateo and SJCC or Gilroy.

IV. PROPOSED MAJOR FORMAT CHANGES

PROPOSAL #1 (TCAL Recommendation):

The number of qualifiers to the Section Finals should be equal to the number of lanes available at the Finals venue. The number of qualifiers in the Field events should increase accordingly as well. For example: If the venue for the Track & Field Finals has nine (9) lanes available, then there would be nine (9) qualifiers for each event coming out of the Semi's.

(approved by a vote of 10-0-0)

Rationale: If the Finals venue has the capacity to accommodate more qualifiers, why not give more kids the chance to be included.

Financial impact: With the potential for more participants in the Finals, there is also potential for an increase of Play-off Fees for some schools/Leagues, as they are charged by the number of participants per event. The current charge is \$5 per participant per event.

There would be a minimal increase in the income by this proposal, due to the potential of increased spectators (parents, etc.) watching more qualifiers.
